WARNING, WAIVER & RELEASE OF LIABILITY & AGREEMENT TO PARTICIPATE.

In consideration of being permitted to participate in anyway, including travel to and from a tournament or related events and activities of the International Budo Federation Australia and it's state and international affiliated bodies and clubs, conducted at various venues throughout Australia and overseas.

I hereby:

1. Acknowledge that I am familiar with the martial art event that I am entering and understand the rules governing the event that I am entering and the importance of following the rules.
2. I agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools and the elimination or scoring system to be used. If I believe anything is unsafe or beyond my capacity in anyway, I will immediately advise my coach or supervisor of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a dangerous contact activity that might result in serious injury, including permanent disability or death, and severe social and economic losses due to not only my actions, inactions or negligence, but also to the actions, inactions or negligence of others, the rules of the competition, or conditions of the premises or of any equipment used. Further I acknowledge that there may be other risks not known, or reasonably foreseeable at this time to me.
4. Knowing the risks involved in martial arts, I assume that risk and accept personal responsibility for the damages following any such injury, permanent disability or death.
5. I release, waive and covenant not to sue the International Budo Federation Australia, or it's affiliated state and international bodies, together with their affiliated clubs, their representatives, administrators, directors, agents, coaches and other employees or any volunteers of the organization, some examples being event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies sponsors, advertisers and if applicable owners, lessors or lessees of the premises used to conduct the events, all of who are herein referred to as "releasees" from any and all claims, demands, losses or damages as a result of injury, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by negligence of the "releasees" or otherwise.
6. I permit photos and filming in which I am seen to be used as a part of the promotion of the I.B.F.
7. Parents and legal guardians of minor participants (17 years and below) additionally agree that they will instruct the minor participant to the above warnings and conditions and their ramifications, and that the consent to the minors participation.

I HAVE READ THE ABOVE WARNING, WAIVER AND RELEASE. I UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND KNOWING THE RISKS AND CONDITIONS INVOLVED AND DO SO ENTIRELY ON MY OWN FREE WILL.
